Business operators shall ensure that the following conditions are complied with at all times during the course of its Food Business Operators Shall:

a true copy of the license granted in Form C shall at all time at a prominent place in the premises.

necessary access to licensing authorities or their authorized personnel to the premises.

authorities about any change or modifications in activities.

at least one technical person to supervise the production process. The person supervising the production process shall have at least a degree in science with Chemistry/ Bio-chemistry/ Food and nutrition/ Microbiology or a degree or diploma in Dairy Technology/ Dairy Microbiology/ Dairy chemistry/ Dairy engineering/ Oil technology/ Veterinary science / Food & Catering technology or any degree or diploma in any other discipline related to the specific requirement of the

from a recognized university or institute or equivalent.

periodic annual return 1st April to 31st March, with in 31st May of each year. For collection/ handling/manufacturing product half yearly return also to be furnished as specified.

that no product other than the product indicated in the license /registration is produced in the unit.

factory's sanitary and hygienic standards and workers hygiene as specified in the schedule-4 according to the process.

daily records of production, raw materials utilization and sales separately.

that the source and standards of raw material used are of optimum quality.

business operator shall not manufacture , store or expose for sale or permit the sale of any article of food in any place not fully separated to the satisfaction of the licensing authority from any privy, urine, sullage ,drain or place of storage or sewer.

clean-in-place system (whatever necessary) for regular cleaning of machine & equipment.

testing of relevant chemical and/or microbiological contaminants in food products in accordance with these regulations as required on the basis of historical data and risk assessment to ensure production and delivery of safe food through accredited /FSSAI recognized labs atleast once in six month.

that as much as possible the required temperature shall be maintained throughout the supply chain from the place of production or sourcing till it reaches the end consumer including chilling, transportation, storage etc.

manufacturer/ Importer/ Distributer shall buy and sell food products only from, or to , licensed /registered vendors and maintain record thereof.

Other Condition

proprietors of hotels, restaurants and other food stalls who sell or expose for sale savouries, sweets or other article of food shall display a notice board containing separates lists of the articles which have been cooked in ghee, edible oil, vanaspati and other fats to the satisfaction of the intending purchasers.

business operator selling cooked or prepared food shall display a notice board containing the nature of articles being sold.

manufacturer (including ghani operator) or wholesale dealer in butter ,ghee ,vanaspti ,edible oils, solvent extracted edible flour and any other fats shall maintain a register showing the quantity of manufactured, received or sold, quantity of de oiled meal and edible flour used etc. as applicable and the destination of each consignment sent out from his factory or place of business, and shall present such register for inspection whenever required by the licensing authority.

producer or manufacturer of vegetable oil ,edible oil and their products shall be edible for license under this act ,unless they have a laboratory facility for analytical testing of samples

sale and movement of stocks of solvents-extracted oil ,'semi refined' or 'raw grade I' , edible groundnut flour or edible oil shall be by the producer shall be a sale or movement of stocks directly to a registered user and not to any other person.
